# BEFORE YOU NOMINATE

The deadline for all nominations is **Sunday 19th February 2023**.

To give your entry the best chances of success, make sure your nomination clearly shows how the nominee demonstrates outstanding standards in line with NFDC's five strategic priorities.

- Safety
- Skills & Training
- Wellbeing
- Sustainability
- Community

As much as possible, provide specific and tangible evidence, including testimonial, picture, and/or video evidence, to help support your nomination.

Members can make a maximum of **two nominations per category**. All nominees for individual awards must be nominated by their employer, who must be a corporate NFDC member.

Supplier of the Year is a self-nominated award open to NFDC ISP members.

## ***Individual awards***

The awards for individuals will be given to the nominees who show outstanding skills and achievement in their category.

Favourable qualities in individual nominees include:

- Upholding high standards
- Excellent health & safety awareness
- Commitment to skills & training
- Progress-driven

All individuals will be anonymised at the point of judging for impartiality.

The Federation will award £1,000 prize money to the winner of all individual awards.

## **CRITERIA** *Individual awards*

### **Apprentice, Labourer, or DRO of the Year**

This award is for the Demolition apprentice, labourer, or demolition & refurbishment operative who has shown outstanding standards in the past year. Nominees will display high skills competence and safety awareness.

Nominees must be directly employed by a corporate member of NFDC and either:

- Be registered on the appropriate apprenticeship course (Trailblazer Demolition Operative L2 Apprenticeship or Specialist Applied Skills Programme (SAP)).
- Hold a valid green CCDO Labourer card.
- Hold a valid blue or red CCDO Demolition & Refurbishment Operative (DRO) card.

Nominators should provide examples of how the nominee has shown exemplary qualities, such as safety awareness, initiative, reliability, high quality of work, and responsibility.

### **Plant Operator of the Year**

This award is for the Demolition Plant Operator who has shown exemplary skills in the operation of demolition plant equipment, while also demonstrating excellent safety standards, over the past year.

Nominees must be directly employed by a corporate member of NFDC and hold a valid blue or red CPCS card with the demolition D90 and/or D92 category.

Nominators should provide examples of how the nominee has shown superior qualities, such as safety awareness, initiative, reliability, high quality of work, and responsibility.

## **CRITERIA** *Individual awards*

### **ADO, Chargehand, or Supervisor of the Year**

This award is for the Advanced Demolition Operative (ADO – formerly Topman), Chargehand or Supervisor who has shown outstanding standards in the past year. Nominees will display leadership, technical knowledge, and safety standards.

Nominees must be directly employed by a corporate member of NFDC and either:

- Hold a valid blue or red CCDO Advanced Demolition Operative (ADO) card.
- Hold a valid silver or red CCDO Chargehand card.
- Hold a valid gold or red CCDO Supervisor card.

Nominators should provide examples of how the nominee has shown exemplary qualities, such as ensuring site safety, training and development of operatives, initiative, and responsibility.

### **Manager of the Year**

This award is for the Demolition Manager who has shown outstanding standards in the past year. Nominees will display leadership, project management skills, safety awareness, and a drive for continuous improvement.

Nominees must be directly employed by a corporate member of NFDC and either:

- Hold a valid black or red CCDO Manager card.
- Hold a valid black or red CCDO Contracts Manager card.

Nominators should provide examples of how the nominee has shown exemplary qualities, such as ensuring site safety, training and development of their teams, successful delivery of projects, initiative, and responsibility.

## Supplier of the Year

This award is for the Industry Service Provider who has added value to the demolition industry by providing exceptional products or services to contractors. In particular, this award will look for suppliers who have worked with contractors to drive progress in the industry.

Nominations should show how the company's efforts have helped drive high standards in one or more areas relating to NFDC's five strategic priorities:

- Safety
- Skills & Training
- Wellbeing
- Sustainability
- Community (inc. social value & charity)

This is a self-nominated award open to NFDC ISP members. Testimonials from contractor members can be added as supporting documents
